Dear Presiding Justice Rubin and Associate Justices:

This letter is in response to the Clerk's request on August 25, 2022 that the parties submit a letter brief on any settlements and dismissals of co-defendants in this matter, and "whether any of these settlements, or other developments pending appeal, have any impact on any issues presently before the court." Plaintiffs respond that the settlements with other defendants do not affect the issues on appeal, and, Plaintiffs are unaware of any other developments that would affect the issues on appeal.

Next, there is no settlement discussion or other negotiation currently pending with the City of Palos Verdes Estates ("City") nor will Plaintiffs entertain such discussion and negotiation given full briefing of the important Coastal Act matters and issues before the Court on appeal. See, also, Fireman's Fund Ins. Cos. v. Quackenbush, 52 Cal. App. 4th 599 (1997); Arden Group, Inc. v. Burk, 45 Cal. App. 4th 1409 (1996); California v. Superior Court (Lovelace), 11 Cal. 4th 50 (1995); 9 Witkin, Cal. Proc. 6th Appeal § 764 (2022).

As a concise update, however, 12 of 17 defendants have settled with Plaintiffs. In alphabetical order, the settling defendants are Brant Blakeman, Cassidy Beukema, Angela Ferrara, Charlie Ferrara, Frank Ferrara, Paul

Hugoboom, Brendon Lamers, Sang Lee, Charlie Mowat, Michael Ray Papayans, Tom Sullivan, and Michael Thiel. Each settling defendant was offered the choice of agreeing to equitable relief in the form of a voluntary stay away, or, paying money. Of the 12 settling defendants, 4 elected the voluntary stay away, 7 elected to pay money, and 1 settling defendant chose a hybrid of voluntary stay away and a payment of money. As to the defendants whose settlement included a voluntary stay away, by stipulation of the parties, the trial court retained jurisdiction over the Plaintiffs and each of the defendants who agreed to the voluntary stay away under Code of Civ. Proc. §664.6 (a), even after dismissal of the matter, until full performance of the settlement.²

The City contested the first Application for Good Faith Settlement Determination (GFSD) made under Code of Civ. Proc. §877.6,³ which was made by settling defendants; the first GFSD was made by Defendants Charlie Ferrara and Frank Ferrara.⁴ After the trial court granted the GFSD,⁵ the City did not file a petition for writ of mandate. Further, after the trial court granted the first GFSD, the City did not challenge the GFSDs made by other defendants.

To assist the Court, a Settlement Agreement Chart is attached as Exhibit A. This chart identifies (1) the settling defendant, (2) the last signature date on the settlement agreement, (3) whether or not the defendant agreed to the Voluntary Stay Away, or chose to pay money instead, (4) the date of the GFSD if one was filed, and, the date of the trial court's order on the GFSD, (5) the date of the dismissal, and (6) the defendants who have not settled.

In conclusion, while this response letter attempts to give the Court a full understanding of the settlements with some of the other defendants, it is Plaintiffs' position that there is no reason to defer full consideration of the pending appeal and resolution of same on the merits.
